Sheriff Presents Awards to Good Samaritans and FCSO Employees

Sheriff Rick Staly hosted the second quarterly awards ceremony on Tuesday afternoon at the Sheriff's Operations Center. The ceremony began by recognizing two Flagler County residents who selflessly rendered aid to complete strangers, and in one case saved a life.

Ladena Rutland received a Certificate of Commendation from Sheriff Staly for driving two juveniles to the Emergency Room after the children were severely injured by fireworks. Ms. Rutland saw the two boys running from the bathrooms near the Dr. Carver Gym and knew that something was wrong. She ushered the boys into her car and drove to Florida Hospital Flagler while on the phone with 9-1-1.

Susan Seitzberg was presented a Lifesaving Award for the care she gave to a 19-year-old gunshot victim on June 24th that ended up at her garage door, bleeding out. Ms. Seitzberg, a registered nurse, held pressure on the wound until paramedics arrived. Hospital doctors reported that without the initial care provided by Ms. Seitzberg, the 19-year-old would not have survived. Ms. Seitzberg addressed the crowd and said that she's a nurse and "that what we do; we try our best to save people who need help."

Sheriff Staly also presented Certificates of Appreciation to local citizens. Anthony Bell was commended for holding a suspect until law enforcement arrived, after Bell found the masked suspect in his daughter's vehicle. His aid allowed law enforcement deputies to arrest the suspect.

Charles Junior McFarlane, Charlie Wicker and Gloria Barton were recognized for volunteering during the weeklong CSI camp that was attended by nearly 40 fourth and fifth graders. Their help allowed the camp to be a success.

Sheriff Staly proudly awarded Chief Paul Bovino the Sheriff's Citation Award in recognition of his dedication and commitment to excellence in the development and implementation of the Sheriff's vision for District Policing.

CS Hicks remained calm while instructing the mother on how to perform CPR. Once the child began breathing, CS Hicks continued instructions on how to sweep clear the airways. CS Hicks is commended for her ability to stay calm and reach quickly in a stressful moment, all while keeping the mother calm and providing life-saving instructions.

In addition to the Employee of the Month Awards, Sheriff Staly honored employees who provided exemplary service in April through June of 2017.

Lifesaving Awards

Deputies Daniel Malta, Christopher Wray and Marcus Dawson received Lifesaving Awards for responding to a motorcycle versus vehicle head-on crash involving severe injuries. All three deputies provided life-saving aid to the driver of the motorcycle.

Sergeant Phil Reynolds received a Lifesaving Award for responding to a medical call where a 71-yearold man was not breathing. Sgt. Reynolds used his AED device at which point the man began to breathe on his own. Sgt. Reynold's actions contributed to saving the man's life.
