Drug House Raided, Four Arrested

The Flagler County Sheriff's Office Special Investigations Unit (SIU) and Community Policing Division executed a search warrant at 21 Fort Caroline Lane in Palm Coast on Sunday afternoon.

A stolen vehicle was located in the driveway of 21 Fort Caroline Lane on Sunday morning. Sheriff's deputies made contact with the owner of the property, Jessica Kumpf Coubrough, who gave deputies consent to search the residence for any persons who may be suspects to the vehicle theft. During the initial search, Sheriff's deputies observed drug paraphernalia in plain view. SIU then responded to the residence to prepare a search warrant.

Sheriff Rick Staly was on the scene with his teams while they conducted the search. A firearm, confirmed stolen from a burglary in the "R" section of Palm Coast, ammunition, Hydromorphone, Alprazolam, methamphetamines, prescription drugs, and drug paraphernalia were all located within the three bedrooms of the residence. Four arrests were made.

"Deputies were watching the house because suspected narcotic activity was taking place there," Sheriff Staly said. "Our patrol deputies did a good job of stopping, or attempting to stop, vehicles leaving from this address [in two previous cases, cars fled from law enforcement that had left this house] and obtaining probable cause for SIU agents to obtain a search warrant. Now more drugs are off the streets, a stolen firearm is out of the hands of felons, and these dirt bags are in the Green Roof Inn where the belong."



Brown, Coubrough, Walsh, and Williams were all arrested at 21 Fort Caroline Lane on Sunday.

Matthew Brown, 23 (DOB 1/13/1994), was arrested for possession of Alprazolam, possession of a controlled substance, possession of methamphetamine, and possession of drug paraphernalia. He is being held at the Flagler County Inmate Facility on an \$8,000.00 bond.

Jessica Kumpf Coubrough, 55 (DOB 3/30/1962), was arrested for possession of methamphetamine and possession of drug paraphernalia. She is being held on a \$3,000.00 bond.

Angelo Thomas Walsh, 35 (DOB 9/7/1982), was arrested for two counts of possession of a firearm or ammunition by a convicted felon, grand theft of a firearm, possession of a legend drug without a prescription, possession of drug paraphernalia, grand theft auto, and driving with a suspended driver's license. He is being held on a \$16,500.00 bond.

Kevin Keith Williams Jr., 35 (DOB 5-6-1982), was arrested for two counts of possession of a firearm or ammunition by a convicted felon, grand theft of a firearm, possession of a legend drug without a prescription, possession of drug paraphernalia, fleeing and eluding, and knowingly driving with a suspended driver's license. He is being held on a \$16,500.00 bond.

All four defendants have lengthy criminal histories and are no strangers to the Green Roof Inn.
