

Sheriff Hosts First Quarter Awards CeremonyGets Surprise Life Saving Award Himself

Sheriff Rick Staly hosted an awards ceremony on Thursday morning at the Sheriff's Operations Center. Members of the community were recognized alongside Sheriff's Office employees for exceptional service. In an unexpected twist for Sheriff Staly, he was awarded a lifesaving award at the ceremony. The woman whose life he saved was in attendance.

On April 11, Sheriff Staly saved a woman's life at an event at the Pine Lakes Golf Club. Sheriff Staly saw Sharon Demers in distress. She was unable to speak but indicated to the Sheriff that she was choking. Sheriff Staly immediately began the Heimlich maneuver. On the fourth attempt, the food was dislodged and the woman was able to breathe again. Without Sheriff Staly's quick reaction and lifesaving response, the situation could have quickly turned tragic. Sheriff Staly was awarded the Life Saving Award at the quarterly award's ceremony by Undersheriff Jack Bisland.

Kaos is a 10-year-old Belgium Malinois who is duel certified in both Patrol and Narcotics. K-9 Kaos has been with the agency since 2009 and has been working with Deputy Fiveash since January 2014. Since January 2014, K-9 Kaos has assisted the Sheriff's Office with nearly 300 K-9 deployments. He has located and/or apprehended over 70+ violent criminal offenders. He assisted the SWAT Team with numerous high-risk search warrants, building searches and area searches, as well as countless narcotics sniffs of vehicles and residences. K-9 Kaos has also assisted deputies in locating several missing juveniles and elderly persons with dementia or Alzheimer. K-9 Kaos has had a positive role in the community with over 30 demonstrations at our local schools, churches and community events.

Soon after the vehicle fled, it crashed which led to the arrest of two subjects and the recovery of the vehicle as well as property from other vehicle burglaries. On February 15, units responded to a possible infant drowning. Detention Deputy Rivas was a few houses down, heard the commotion, and responded to the residence. Her bilingual ability was key in providing the father CPR instructions. Deputy Malheiros arrived soon after and began resuscitating the infant until she was breathing on her own again. The child is in good health and just celebrated her second birthday back at her home in Honduras. Deputy Rivas receives a Certificate of Commendation for a job well done.

The Special Investigations Unit has been working diligently to combat drugs on the streets in Flagler County to make it a safer place. Detectives received information from a confidential informant about a possible drug house in Palm Coast. On March 1st, Detectives executed a search warrant for the residence and seized nearly 7 pounds of illegal drugs and \$46,000 in drug money. The Special Investigations Unit is making a difference in this community and getting drug dealers off the streets.
