## RING Camera Aids Law Enforcement in Stolen Truck Recovery

A homeowner on Llobell Place in Palm Coast notified the Flagler County Sheriff's Office that three males were seen on their Ring camera running from their driveway.

Deputies responded to conduct an investigation to determine if any crimes had been committed. During a canvass of the neighborhood, a vehicle was determined to be stolen from 27 Lloshire Path, left unlocked with the keys inside the vehicle. The vehicle was a gray 2003 Dodge Ram 1500 pickup truck with various work related items in the bed of the truck, including a chainsaw, a cooler, and oil. A "be on the lookout" (BOLO) alert was sent to neighboring agencies regarding the stolen vehicle.

One-and-a-half minutes after the BOLO was issued, Bunnell Police Officer Groth located the stolen vehicle driving recklessly before getting stuck in the mud on Hymon Circle in Bunnell. Four subjects fled from the vehicle but Officer Groth was able to apprehend one subject.

A perimeter was established by FCSO deputies and Volusia County Sheriff's Office's AirOne helicopter responded. The three additional subjects were located and taken into custody.

Kano Gillislee, DOB 07-26-03, Ah’Nyis E Johnson, DOB 04-30-04, Devandre Williams, DOB 05-16-04, and Steven Dozier, DOB 09-23-03 were all placed under arrest and charged with Grand Theft Auto as well as Resisting an Officer without Violence. Kano and Ah’Nyis were placed on Home Detention Supervision pending a detention hearing by the Florida Department of Juvenile Justice (DJJ). DJJ ordered Devandre and Steven released to their parents.

“This was a great team effort between FCSO, the Bunnell Police Department and the Volusia County Sheriff’s Office. We appreciate their assistance,” Sheriff Rick Staly said. “This is a reminder to always lock your car doors and do not leave your keys in your vehicle to help us prevent crimes of opportunity. This is also another great example of ‘see something, say something’ and I thank the alert resident who called us to report the suspicious activity.”

Miscellaneous items were located inside the vehicle and placed in evidence until a victim(s) can be identified. The vehicle was returned to its owner.
