The Flagler County Sheriff's Office (FCSO) received a complaint of a sexual battery on December 19, 2017. The victim believed that she had been drugged and victimized several days prior at a private residence in Beverly Beach.

According to the victim, the suspect had given her and her friend some alcoholic beverages which caused both of them to lose consciousness. Both women reported that they had some loss of memory from the one drink that each of them had consumed.

The case was assigned to the Major Case Unit for investigation. During the investigation, the suspect was identified as Larry Cavallaro of Winter Park, Florida. Through various investigative means, and with the assistance of the Federal Bureau of Investigation and the FBI Crime Laboratory in Quantico, VA., detectives were able to obtain an arrest warrant on Larry Cavallaro on Friday, June 7, 2019.

"This is another outstanding job by our Major Case detectives," said Sheriff Rick Staly. "These are difficult cases that take time to build. I commend Detective Cpl. Hristakopoulos for his perseverance to prove through the evidence that the suspect sexually assaulted his victim. It's now time for him to face the consequences of his actions. We are working with other agencies to locate and apprehend him as quickly as possible before he can assault someone else."

Once arrested Judge Distler set the defendant's initial bond at NONE and authorized a nationwide extradition on the suspect. The Flagler County Sheriff's Office Fugitive Unit is currently attempting to locate the suspect. "We will get him," said Sheriff Staly. "It is only a matter of time before he is in the Green Roof Inn."
