Person of Interest in Gray Homicide Arrested

Teresa Selgado aka "Alex" Update

The Flagler County Sheriff's Office (FCSO) made contact with a person of interest in the Gray homicide investigation, Teresa Selgado AKA "Alex" on Thursday, April 18th. Salgado was uncooperative and invoked her rights to an attorney.

Detective Rodriguez informed Salgado of pending charges from a traffic stop on January 15th that she was involved in where a substance was sent to FDLE for analysis. Recent results from the lab confirmed the substance was LSD, a synthetic crystalline compound that is a potent hallucinogenic drug.

A warrant was obtained on Thursday afternoon for Salgado. The charge is Possession of LSD. Detectives with assistance from Flagler Beach Police Department located and arrested Salgado in Flagler Beach on Thursday afternoon. She was transported to the Sheriff Perry Hall Inmate Detention Facility for booking where she will be held on a \$5,000.00 bond.

"We want to thank the community for the tips to help locate Salgado," Sheriff Rick Staly said. "I've said before that you can run and hide from us but you will only go to jail tired as we will find you. Salgado is proof that we do not give up!"

Gray Homicide Investigation Still Ongoing, Detectives Actively Investigating all Threats Still Seeking to Speak with Teresa Selgado aka "Alex"

The Flagler County Sheriff's Office (FCSO) is still actively investigating this case and seeking to make contact with other witnesses. There have been reports of threats of retaliation against witnesses. Let it be known that each of those instances will be investigated fully by FCSO and those engaged in such threats could potentially face charges for either written threats to kill or witness tampering. Both crimes are felonies under Florida Law.

The FCSO encourages anyone with information in this investigation to call FCSO at 386-313-4911 or email tips to TIPS@flaglersheriff.com. Anyone who feels they are being threatened or that someone is attempting to influence their testimony should report that to the FCSO by calling 911 in an emergency, or 386-313-4911 in a non-emergency.

The FCSO is still seeking to speak with Teresa Selgado aka "Alex." She is not considered a suspect. We encourage her to provide contact information to the FCSO through either TIPS@flaglersheriff.com or by calling 386-313-4911.

"Learn from the mistakes of others that violence is not going to solve your problems," Sheriff Rick Staly said. "Don't let another life be ruined or lost to senseless violence."

Marion Gavins Jr. in Custody, Charged with First-Degree Murder

Flagler County Sheriff's Office (FCSO) deputies and detectives have arrested Marion Lee Gavins Jr., age 17, of Palm Coast, and charged him with First Degree Murder following the death of 18-year-old Curtis Israel Gray early Saturday morning.

Through the investigation, it was revealed that an altercation occurred outside the Coin Laundry on Belle Terre near Palm Coast Parkway. Deputies and Sheriff's detectives were able to interview witnesses and quickly identify a possible suspect.

"Our detectives worked swiftly and strategically to solve this murder investigation and were able to take Gavins Jr. into custody without anyone else getting hurt," Sheriff Rick Staly said. "This is a tragedy for two families, one who lost a son who was an aspiring athlete and the other whose son will likely spend the rest of his life in prison or face the death penalty. I hope this fast arrest will help the Gray family with their loss."

Deputies conducted a felony traffic stop on a car leaving the suspect's house on Saturday afternoon. Deputies along with our SWAT team served a search warrant at 23 Woodfaire Lane in Palm Coast on Saturday afternoon. The vehicle the suspect was in during the shooting was located in the garage but the suspect was not in the home and was not in the car previously stopped.

Around 2:00 p.m. on Sunday, deputies spoke with Gavins' mom. She agreed to meet at the Sheriff's District 2 Office in Palm Coast. At 3pm today Gavins turned himself in, with his mom present, and was arrested.

Gavins has a criminal arrest history dating back to 2014. He was arrested in October of 2014 for sale of marijuana within 1,000 feet of a school. In 2015, he was arrested for violation of probation and possession of a weapon on school campus (an 8-inch kitchen knife). In 2016, he was arrested for domestic violence.

FCSO Seeks Community's Help in Locating Murder Suspect

The investigation into the death of 18-year-old Curtis Israel Gray early Saturday morning has led Flagler County Sheriff's Office (FCSO) detectives to identify 17-year-old Marion Leo Gavins Jr., DOB 5/16/2001, of 42 Woodlyn Lane in Palm Coast, as the suspect.

At this time, the FCSO is requesting the help of the community in locating Marion Gavins. A warrant for First Degree Murder has been issued for Gavins' arrest.

"If you know where he may be or any information regarding this shooting, please call us," Sheriff Rick Staly said. "Do not approach him. He should be considered armed and dangerous. To Gavins I say turn yourself in before you or anyone else is hurt."

Anyone with information on the location of Marion Gavins is asked to contact FCSO at 386-313-4911 and mention Case No. 2019-34712. You may also call Crime Stoppers at 1-888-277-TIPS (8477) where you could be eligible for a reward up to \$5,000.00.

The Flagler County Sheriff's Office (FCSO) responded to Palm Coast Laundry, located at 4845 Belle Terre Parkway in Palm Coast, shortly after 12:30 a.m. on Saturday morning. Deputies found an 18-year-old male with a gunshot wound who was immediately airlifted to a trauma hospital. The victim, Curtis Israel Gray, later succumb to his injuries.

FCSO Detectives and Deputies are actively investigating the incident and following all leads. This is believed to be an isolated incident and there is no immediate danger to the community.

"This is a very sad day for the families of those involved and we are following all leads to find out exactly what happened," Sheriff Rick Staly said. "We will release more information when it is appropriate."

Further details will be released as the investigation continues.
