## "See Something, Say Something" Leads to **Narcotics Arrests**

On Sunday, September 19, 2021, the Flagler County Sheriff's Office (FCSO) responded to a call about suspicious activity occurring on Blueberry Street in Bunnell. The occupants of this house are known to law enforcement to be frequently involved in theft, narcotics, and burglary.

As deputies arrived they observed a U-Haul truck, with Hayworth sitting in the truck. In the U-Haul truck there are two motorcycles. Deputies suspected these motorcycles were stolen and ran the tag and determined one was reported stolen. Upon questioning, Driggers and Hayworth claimed they bought the motorcycle from someone in Deland, Florida.

Deputies asked Hayworth and Driggers for documentation to prove they owned the motorcycle but they could not provide any. Hayworth asked deputies for her purse to call her friend who has the documentation. As deputies looked through Hayworth's purse to locate her phone, they located a small red zippered bag. Inside the bag was a glass smoking pipe with a white residue and burn marks on it. The pipe is one typically used to smoke Methamphetamines. Deputies also found two smaller ziplock baggies with crystal-like residue inside. The substance was field-tested by deputies, which was positive for methamphetamines. The motorcycle was later determined to not be stolen.

Tara Hayworth and Clyde Driggers are no strangers to law enforcement. In fact, they were out on bond from Volusia County after being arrested for Trespass in an Unoccupied Structure or Conveyance, Petit Theft, and Possession of Drug Paraphernalia.

"This is another example of 'see something, say something'," said Sheriff Rick Staly. "A neighbor saw something suspicious and called the Sheriff's Office to report suspicious activity, which resulted in these arrests and narcotics off the streets."

Tara Hayworth was arrested and transported to the Sheriff Perry Hall Inmate Detention Facility. She was arrested for Possession of Methamphetamine and Possession of Drug Paraphernalia Equipment. She is being held on a \$3,000 bond.
