UPDATE: 14-Year-Old Accomplice in Armed Robbery at Carver Gym Identified and Arrested, Facing Felony Charges

Late Thursday, the Flagler County Sheriff's Office arrested 14-year-old Lawrence Fulmore for his involvement in last Thursday's violent robbery with a weapon at the Carver Gym in Bunnell.

During the incident, the victim reported two black males robbed him, stealing his phone and money from his pockets, and stated one of the males pistol-whipped him during the encounter. Detectives working the case initially obtained a warrant for the arrest of the other male involved, identified as 19-year-old Keyshawn Davis, who was arrested last Saturday while the investigation continued.

Utilizing investigative techniques, detectives were able to identify Fulmore as the second suspect and received a signed "Order to Take Juvenile Into Custody" yesterday. With the assistance of FCSO's PACE Team and Major Case Unit (MCU) Detectives, Fulmore turned himself in.

Fulmore is no stranger to law enforcement, with a criminal history dating back to 2020, when he was just 12-years old. He was previously arrested for Sexual Assault and Kidnap Child Under 13 Years Old. He was sentenced to probation by a Juvenile Judge under the supervision of the Department of Juvenile Justice for the Sex Assault.

“This was great detective work building the case and getting the second suspect to turn himself in,” Sheriff Rick Staly said. “These kids are young, playing with weapons and escalating their crimes. Parents – I’m begging you to get involved in your kid’s life and know where they are, what they’re doing and who they’re associating with. Fulmore started committing serious crimes when he was just 12-years old. I hope the State Attorney charges him as an adult before he escalates into seriously hurting or killing someone. Obviously, the juvenile justice system can’t handle him.”

Fulmore was arrested without incident for Robbery with a Weapon and was transported to the Sheriff Perry Hall Inmate Detention Facility. He was released to the custody of the Florida Department of Juvenile Justice (DJJ).

Additional charges are pending as the investigation continues.

19-Year-Old Career Felon Back Behind Bars for Robbery with a Weapon

Yesterday evening, the Flagler County Sheriff’s Office (FCSO) executed a Search Warrant at 504 S. Church Street in Bunnell after an arrest warrant was granted for 19-year-old Keyshawn Davis. He was wanted for Robbery with a Weapon for an incident that occurred the day prior, where the victim reported being beaten and robbed by Davis at the Carver Gym in Bunnell.

On Thursday afternoon, the Sheriff’s 9-1-1 Dispatch Center received a call from a male advising he was robbed while at the Carver Gym and the Bunnell Police Department (BPD) responded. The victim reported that two black males took his phone and money from his pockets and one of the males pistol-whipped him during the incident. Due to the totality of the circumstances, the investigation was

launched and turned over to the FCSO Major Case Unit (MCU).

Utilizing investigative techniques, detectives were able to identify Davis as the suspect and received a signed warrant for his arrest. Around 9 p.m. last night, the FCSO SWAT Team arrived to his address and observed Davis approaching his residence. He was immediately secured without incident.

“Another dirtbag thought he could get away with violence into my county,” Sheriff Rick Staly said. “This 19-year-old’s criminal history is extensive and it’s clear he won’t learn to abide by the laws. Just last year, this young career felon was arrested after a traffic stop resulted in the recovery of a stolen firearm, \$15,000 cash and drugs. This is another great example of law enforcement agencies working together, and we appreciate the partnership we have the Bunnell Police Department! A reminder to the community that all acts of violence will be investigated, and we will not tolerate it in Flagler County.”

Davis’ criminal history in Flagler dates back to 2020. He’s previously been arrested for Possession of Cocaine with Intent to Sell, Unlawful Use of a 2-Way Communication Device, Operating a Motor Vehicle without a Valid Drivers License, Carrying a Concealed Firearm and Grand Theft of a Firearm.

Davis is residing at the Green Roof Inn for the sixth time. He’s facing charges for Robbery with a Weapon and being held on \$100,000 bond.
