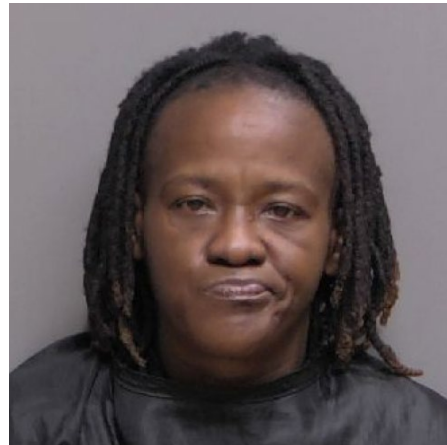

## **UPDATE: Additional Suspect and Career Felon Arrested in May Armed Robbery at Carver Gym**

An armed robbery at the Carver Gym in Bunnell on May 26 has resulted in an additional arrest of 36-year-old Delise Lacy who was arrested for Petit Theft and Dealing in Stolen Property.

On May 27, the Flagler County Sheriff's Office (FCSO) deputies served a Search Warrant at a residence in Bunnell where Keyshawn Davis was wanted for an armed robbery that occurred the day prior. Ultimately, Davis was arrested for Robbery with a Weapon while the investigation continued.

Utilizing investigative techniques, detectives continued the investigation into the robbery leading to evidence of an additional suspect, identified as Lacy. Deputies were able to locate where she sold the cell phone and had used her identification to complete the sale. On June 23, Lacy was located in South Bunnell and confessed to her involvement. A warrant was signed for her arrest the following day.

No stranger to law enforcement, Lacy has a criminal history in Florida dating back to 2010. She's previously been charged with Contempt of Court, Aggravated Assault with a Deadly Weapon, Battery, Driving While License Suspended/Revoked, Violation of Probation, Trespassing, Failure to Appear,

Possession of Marijuana, Use Invest Proceeds from Racketeering Activity, Drug Possession, Possession of LSTD Chemical for Manufacture Controlled Substance and Manufacturing Methamphetamine.

“Another career felon kicked off the weekend with Ladies Night at the Green Roof Inn,” Sheriff Rick Staly said. “She thought she was going to get away with being part of a violent crime in Flagler County and was mistaken. This is a reminder to criminals that we don’t play around and will do everything to ensure those who do the crime, do the time. Great work to PACE and detectives who continued to investigate this case.”

On June 24, Lacy was located and arrested without incident for Petit Theft and Dealing in Stolen Property. She’s currently being held at the Sheriff Perry Hall Inmate Detention Facility on a \$26,000 bond.

## 19-Year-Old Career Felon Back Behind Bars for Robbery with a Weapon

Yesterday evening, the Flagler County Sheriff’s Office (FCSO) executed a Search Warrant at 504 S. Church Street in Bunnell after an arrest warrant was granted for 19-year-old Keyshawn Davis. He was wanted for Robbery with a Weapon for an incident that occurred the day prior, where the victim reported being beaten and robbed by Davis at the Carver Gym in Bunnell.

On Thursday afternoon, the Sheriff’s 9-1-1 Dispatch Center received a call from a male advising he was robbed while at the Carver Gym and the Bunnell Police Department (BPD) responded. The victim reported that two black males took his phone and money from his pockets and one of the males pistol-whipped him during the incident. Due to the totality of the circumstances, the investigation was launched and turned over to the FCSO Major Case Unit (MCU).

Utilizing investigative techniques, detectives were able to identify Davis as the suspect and received a signed warrant for his arrest. Around 9 p.m. last night, the FCSO SWAT Team arrived to his address and observed Davis approaching his residence. He was immediately secured without incident.

“Another dirtbag thought he could get away with violence into my county,” Sheriff Rick Staly said. “This 19-year-old’s criminal history is extensive and it’s clear he won’t learn to abide by the laws. Just last year, this young career felon was arrested after a traffic stop resulted in the recovery of a stolen firearm, \$15,000 cash and drugs. This is another great example of law enforcement agencies working together, and we appreciate the partnership we have the Bunnell Police Department! A reminder to the community that all acts of violence will be investigated, and we will not tolerate it in Flagler County.”

Davis’ criminal history in Flagler dates back to 2020. He’s previously been arrested for Possession of Cocaine with Intent to Sell, Unlawful Use of a 2-Way Communication Device, Operating a Motor Vehicle without a Valid Drivers License, Carrying a Concealed Firearm and Grand Theft of a Firearm.

Davis is residing at the Green Roof Inn for the sixth time. He’s facing charges for Robbery with a Weapon and being held on \$100,000 bond.
