## <u>WEEKEND ROUNDUP: Orlando Man Back in Jail After</u> <u>Violating Felony Probation for Second Degree Murder of</u> <u>13-Year-Old Boy</u>

Male With Warrant for Sexual Assault of a Minor Arrested | Several Narcotics Arrests

**BUNNELL, FL** – A male who violated his probation for second-degree murder by driving without a license, a male with a warrant for sexually battering a minor, and several narcotics-related offenses are among the notable incidents that occurred within Flagler County this weekend.

The Flagler County Sheriff's Office (FCSO) responded to 938 calls for service between 6:00 a.m. Friday (November 4, 2022) and 6:00 a.m. Monday (November 7, 2022) and performed 238 traffic stops. 13 arrests were made over the weekend, according to Flagler County Sheriff Rick Staly.

"Another weekend of hard work by our Deputies bringing criminals to justice at the Green Roof Inn," Sheriff Staly added.

Below are more details on the notable incidents from this past weekend.

#### Male on Felony Probation for Second Degree Murder Arrested After Driving Without a Valid Driver's License

A male on felony probation for murdering a 13-year-old boy in Orlando in 2009 was arrested by Flagler County Sheriff's Deputies on Saturday for violating the terms of his probation. 35-year-old Tarod Weaver of Orlando was stopped while driving near Pritchard Drive and Belle Terre Parkway.

Weaver advised to deputies during the traffic stop that although he was the driver of the vehicle, he does not possess a driver's license. Weaver was subsequently arrested for driving without a license, which is a violation of his probation. Weaver was taken to the Flagler County Inmate Facility without incident.

#### Wisconsin Man on a Warrant for Sexually Battering a Minor Arrested in Flagler County

Jamar Walker Jr. was taken into custody by Flagler County Deputies for a warrant in reference to sexual battery of a person under the age of 18 on Saturday. Between the years of 2016 and 2018, Walker Jr., who was between the ages of 14-16 years old at the time of the alleged offenses, sexually battered a juvenile victim multiple times while the victim was between the ages of 9-12 years old.

#### Duo Arrested for Drug Possession, Other Charges

A duo has been arrested after an FCSO Deputy witnessed them engage in a disturbance outside the Microtel located at 16 Kingswood Drive, Palm Coast, on Saturday.

After contacting the couple, the male, later identified as Tristan Marino, provided a false name to Deputies. Marino stated that he provided a false name because he believed that there was an active warrant for his arrest. While conducting a search of the vehicle, Deputies located several used hypodermic needles and other drug paraphernalia as well as a shotgun on the rear passenger floorboard.



The female, identified as Jennifer Chunn, is a convicted felon with a criminal history of lewd and lascivious behavior dating back to 2007. Chunn stated she was aware the shotgun was in the vehicle. Following her being placed under arrest for possession of a firearm by a convicted felon, Chunn advised Deputies that she had several grams of narcotics concealed within her female sexual organs. Within her body was 3.90 grams of methamphetamine, 0.71 grams of heroin, and 1.16 grams of fentanyl. She was additionally charged with possession of methamphetamine, heroin, and fentanyl.

#### **Traffic Stop Leads to Arrest**

On Sunday, Flagler County Deputies located a vehicle traveling on West Moody Boulevard and initiated a traffic stop due to the registered owner of the vehicle having a suspended license and an expired vehicle registration. Upon making contact with the driver, he refused to identify himself and became verbally aggressive. The occupant was later able to be identified as Mark Anthony Smith of Orlando.

During a search of the vehicle, Deputies located marijuana and other drug paraphernalia. Smith was charged with knowingly driving with a suspended license, possession of marijuana, possession of hashish, possession of drug paraphernalia, and resisting an officer without violence.
