## **Sex Offender Re-Arrested, Inmate Exposes Himself to Female Deputies, Pervert Records Female in Bathroom**

BUNNELL, FL - [A Palm Coast man who shot at several people within a Palm Coast bar](#) and several perverts who preyed on females within Flagler County are among 14 people taken to the Green Roof Inn during a busy weekend for the Flagler County Sheriff's Office (FCSO).

875 calls for service were handled between 6:00 a.m. Friday (November 18, 2022) and 6:00 a.m. Monday (November 21, 2022) along with 191 traffic stops according to Sheriff Staly.

"Unfortunately, several perverts were out and about within Flagler County this weekend," Sheriff Staly added. "Two of them are currently in the Green Roof Inn, and the third will be as soon as we are able to identify them."

Below is a summary of the more notable incidents from the weekend.

### **Person Wanted for Video Voyeurism After Recording a Female in Bathroom Stall**

FCSO is attempting to identify a suspect who is accused of videotaping or photographing a female while she was using the restroom at the Publix store located at 5415 North Ocean Shore Boulevard on Friday.

The victim noticed the person in the stall next to her had unusually large feet for a female and that the subject's feet were facing the toilet. The victim became uncomfortable and began to gather her belongings to exit the stall when she noticed the subject was holding a cell phone over the stall wall pointing toward her. The victim yelled "Stop!" and the subject exited the bathroom quickly. The subject was last seen running out of the store and then running north on A1A from Publix.

The subject is described as being a white male, 5'7-5'8, approximately 200-250 pounds, late teens or early 20s, with dark blonde curly hair wearing camouflage crocs, grey sweatpants, and a black hoodie. 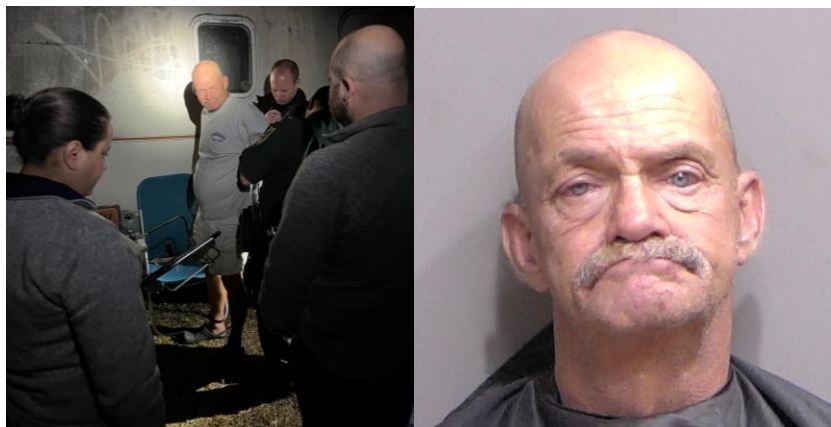
*Suspect in Video Voyeurism Case*

### **55-Year-Old Sex Offender Back in Jail After Inappropriately Kissing a Young Girl Inside His Trailer**

55-year-old David Futch of Bunnell was arrested on Saturday after luring a female under the age of 10 into his trailer and kissing her on the forehead, cheek, and lips. The juvenile victim explained to Detectives that she felt uncomfortable and later told an older sister about the incident who reported it to an adult. The adult then contacted the Flagler County Sheriff's Office.

Detectives responded and made contact with Futch who claimed that his actions were his way of saying goodbye to the child. Futch was arrested and transported to the Sheriff Perry Hall Inmate Detention Center without incident. Futch was already a registered sex offender on probation for failing to register his address. Futch was charged with battery and violation of probation – felony. He is being held at the Flagler County Inmate Facility with no bond.

“This could have been a much more serious case,” added Sheriff Staly. “This is why it is so important to know where your children are and who lives near you.”

## **Green Roof Inn Inmate Charged for Exposing Himself to Female Detention Deputies**

On Sunday, Deputies responded to the Flagler County Inmate Facility after an inmate had reportedly become irate and exposed his genitals to two female FCSO Detention Deputies.

Contact was made with the two Deputies who explained that 59-year-old inmate Steven Sileo became irate during meal distribution and had attempted to spit on the Detention Deputies through the small opening of the door. After being unsuccessful, Sileo reportedly removed all of his clothing and began masturbating in full view of the female Detention Deputies.

Sileo was charged with lewd or lascivious exhibition in the presence of an employee. He remains in the Sheriff Perry Hall Inmate Detention Facility with no bond. His previous charges include grand theft of a motor vehicle, driving with license suspended with knowledge, and criminal mischief.

## **14- Year-Old Arrested for Threatening to Blow Up Flagler Palm Coast High School**

FCSO Deputies responded to a delayed threat to Flagler Palm Coast High School. The reporting party, who is a parent of a student, reported that their child observed a post on Instagram referencing Flagler Palm Coast High School “going kaboom.”

Deputies identified the subject as a 14-year-old who attends FPCHS. Deputies made contact with the male at his residence who advised that the post was a joke between himself and his friends. The subject was arrested and transported to FCIF for processing and then turned over to the Department of Juvenile Justice where he remains.

“Parents need to be the Sheriff in your home,” said Sheriff Staly. “You also need to talk to your children that comments like this will only get them arrested. Saying it’s a joke is to late to avoid arrest. Just don’t do it.”

## **A Traffic Stop for Window Tint Leads to Two Arrests for Narcotics Offenses**

FCSO Deputies initiated a traffic stop for a window tint violation near US1 and Old Dixie Highway in Bunnell. The driver of the vehicle was identified as Audrey Perro who had three prior convictions for driving with a suspended license and had had her license revoked in 2009. Perro was also deemed a habitual traffic offender in 2009.

FCSO Deputy Sheriff Beausoleil and K-9 Axle responded to the scene and alerted to narcotics within the vehicle. Upon search of the vehicle, Deputies located 1.2 grams of fentanyl in the glove box as well as a similar white powder in Perro's purse. The registered owner of the vehicle, Joe Hopkins, who was in the passenger seat, was placed under arrest and charged with possession of fentanyl, possession of drug paraphernalia, maintaining a nuisance vehicle, and permitting an unauthorized operator to drive.

Perro was charged with driving with license suspended with knowledge (3<sup>rd</sup> offense or subsequent offense), driving with license suspended as a habitual traffic offender, possession of fentanyl, and possession of drug paraphernalia. Perro was also issued several traffic citations.

Both subjects were transported to the Sheriff Perry Hall Inmate Detention Facility without incident. Upon booking, an additional .2 grams of fentanyl were found on Hopkin's person. Hopkins was additionally charged with introducing contraband into a county detention facility.

Hopkins is being held on \$11,500 bond, and Perro is being held on \$6,500 bond. Neither have a criminal history in Flagler County, although Hopkins has a significant criminal history in Volusia County including grand theft, fraudulent use of personal ID information, battery on a law enforcement officer, and leaving the scene of a crash with injuries, among others.
