Weekend Roundup January 27-30

Sheriff Staly Apprehends Fleeing Driver and Stops Impaired Driver Among Several Weekend DUI Arrests

BUNNELL, FL – Several drunk drivers were among 7 arrests made last weekend by the Flagler County Sheriff's Office (FCSO) between 6am on January 27, 2023, and 6am on January 30, 2023. Over the weekend, deputies handled 868 calls for service along with 114 traffic stops.

"Deputies were able to get several impaired drivers off Flagler County roadways this past weekend before they could hurt or kill anyone," said Sheriff Rick Staly. "Thank you to the citizen who kept a drunk driver from continuing to operate his vehicle after he had already crashed several times, allowing deputies to place him under arrest."

Below is a summary of the more notable calls from over the weekend.

Sheriff Staly Assists VSO in Arrest of Fleeing Driver in Flagler County

On Friday afternoon, Volusia Sheriff's Office deputies attempted a traffic stop on a blue Mercedes traveling north on I-95. The driver, later identified as Zachary Teytelbaum, took off at high speed and drove recklessly into Flagler County.

Teytelbaum ultimately gave up and was taken into custody in Flagler County by Sheriff Rick Staly, VSO Chief Deputy Brian Henderson, and deputies from both agencies. Teytelbaum was charged with Aggravated Fleeing or Attempting to Elude Law Enforcement and booked into the Sheriff Perry Hall Inmate Detention Facility and later released after posting \$5,000 bond.

Sheriff Rick Staly Stops Impaired Driver on I-95

On Friday night, a reckless driver was reported to FCSO Communications who was reportedly traveling northbound well below the posted speed limit on I-95. The driver was traveling in the center lane of I-95 between 25 and 30 miles per hour, posing a danger to other motorists on the highway.

Sheriff Rick Staly located the vehicle while on his weekly Friday night patrol and conducted a traffic stop. Contact was made with the operator, 19-year-old Asher Maduro. Deputies could smell the odor of burnt cannabis emanating from within the vehicle and Maduro presented with bloodshot, watery, and glassy eyes. While conducting a search of the vehicle, deputies located a green leafy substance consistent with marijuana which produced a presumptive positive result for cannabis containing over 0.3% of THC.

Maduro was subsequently placed under arrest for DUI and was transported to the Sheriff Perry Hall Inmate Detention Facility. Maduro was later released after posting \$250 bond.

Convicted Felon Arrested for DUI, Possession of a Firearm

On Sunday, deputies conducted a traffic stop after witnessing a vehicle traveling approximately 70 miles per hour in a posted 45-mile-per-hour zone and failing to maintain a single lane – leaving the roadway and nearly striking a tree.

Upon making contact with the driver, later identified as Delilah Fennell, deputies noticed the vehicle's emergency brake had been engaged while the vehicle was operating and all four brakes were smoking heavily. As Fennell was looking for her driver's license, deputies observed a .380 caliber handgun in her purse. Fennell was found to be a convicted felon who had been convicted of Battery on a Law Enforcement Officer and on Florida Inmate Release Status for the same charge.

The Florida Highway Patrol responded and conducted a DUI investigation, and Fennell was additionally charged with DUI after testing nearly 3 times the legal limit on a breath test. She was transported to the Sheriff Perry Hall Inmate Detention Facility on charges of DUI over .15 1st Offense and Possession of a Firearm by a Convicted Felon and later released after posting \$3,500 bond.

Drunk Driver Arrested After Crashing Several Times

On Sunday, several callers contacted FCSO Communications in reference to a possibly intoxicated driver who was observed striking several objects with his vehicle. The first caller advised that a red sedan with severe front-end damage had struck a speed limit sign and then turned into the F-section of Palm Coast.

The second caller advised that he was driving in the F-section when a red sedan almost struck his vehicle and that he had to take evasive action to avoid a collision. The second caller followed the red sedan and witnessed it crash into another vehicle on Old Kings Road. The second caller confronted the driver of the red sedan and secured the operator of the vehicle until deputies could arrive on scene.

Upon deputies arrival on scene, the driver of the red sedan, later identified as Robert Ulloa, was visibly impaired and a strong odor of alcohol was emanating from his breath. After performing field sobriety

386-437-4116 - Fax 386-586-4888 www.flaglersheriff.com exercises, Ulloa was placed under arrest for DUI. Ulloa was transported to the Sheriff Perry Hall Inmate Detention Facility where his BAC was measured to be three times over the legal limit.

Ulloa was charged with DUI .08 or Higher and leaving the scene of a Crash with Damage to Vehicle or Property and later released after posting \$2,000 bond. He was also issued several uniform traffic citations.
