5 Arrested for Narcotics by FCSO in Under 12 Hours

BUNNELL, FL – Early Tuesday, March 14, 2023, Deputy Gaddie conducted a traffic stop at SR100 W and Bimini Lane due to the vehicle being unregistered. Upon a probable cause search of the vehicle, deputies located a large black duffle bag with 4 pounds of marijuana as well as other narcotics and paraphernalia within the vehicle.

The driver of the vehicle, identified as Kelly Perez, was placed under arrest for Possession of Marijuana with Intent to Sell/Manufacture/Deliver, Manufacture/Deliver Drug Paraphernalia, Motor Vehicle – Fail to Register, Attached Tag Not Assigned. She was transported to the Sheriff Perry Hall Inmate Detention Facility and later released after posting \$5,400 bond.

The passenger, identified as Alfredo Rivera Aguilera, was placed under arrest for Possession of Marijuana with Intent to Sell/Manufacture/Deliver, Possession of Cocaine, and Manufacture/Deliver Drug Paraphernalia. He was transported to the Sheriff Perry Hall Inmate Detention Facility and later released after posting \$7,500 bond.

Earlier in the night, Deputy Harrison and Deputy M. Dorsey observed a female who appeared to be Proudly Serving the Community Since 1917 A Four Diamond Accredited Law Enforcement Agency









tampering with a license plate in a local gas station parking lot. They had observed the same female at a known drug house earlier in the day.

While speaking to the female, later identified as Cynthia Metzler, deputies observed drug paraphernalia in plain view within the vehicle. Metzler and a second female on scene, Stephanie Robinson, were then detained.

Upon a probable cause search of the vehicle, narcotics and paraphernalia were located including Oxycodone, Hashish, and Marijuana. Metzler was placed under arrest for Possession of Oxycodone, Possession of Hashish, Possession of Marijuana, and Possession of Drug Paraphernalia/Equipment. She is being held at the Sheriff Perry Hall Inmate Detention Facility on \$6,000 bond. Robinson was arrested for Possession of Drug Paraphernalia/Equipment.

Also that night, Deputy Gaddie made contact with a female with narcotics inside her purse. Brandy Gochenouer was arrested for Possession of Fentanyl, Possession of Methamphetamine, and Possession of Drug Paraphernalia.
