D-1 fled from the scene of the crash and continued south into Volusia County. A witness followed D-1 to the 275 mile marker, where her Jeep became disabled. A sworn statement was obtained from the witness confirming D-1 as the driver. D-1 was issued a criminal UTC for leaving the scene of an accident. VCSO deputies additionally charged D-1 with DWLS with knowledge and possession of felony narcotics.
