Disturbance Domestic / 92484-17 / Wendover Ln, Palm Coast / Sector 221 / V1 and W1 (witness) reported that D1 (defendant) began yelling at everyone at the residence then grabbed a knife while yelling at everyone putting the family in fear for their safety and to call 911. Another family member was able to get the knife from him prior to LEO arrival. Family did not speak English and language line was utilized. D1 arrested for aggravated assault with a deadly weapon. Burglary-Residential/92426-17/Red Clover/Red Barn, Palm Coast/Sector 222/A male advised that his adult grand daughter entered his home and stole items. Upon making contact with the female at the above intersection, there has been an ongoing issue between the two about personal property and living arrangements. While interviewing the female, she advised she wanted to harm herself. The female was transported to Act for treatment by law enforcement. ### **Non-Part One Crimes: Missing Persons, Traffic Fatality, Use of Force, Weapons**

Ex-Parte Order/92417-17/Old Kings Rd. (Planet Fitness)/Sector 212/Subject was located at the fitness center and transported to Act per the court order (Ex-parte) by law enforcement.

Narcotics/92437-17/Palm Coast Pkwy, Palm Coast/I-95/Sector 212 /Deputy Conway conducted a traffic stop for no brake lights. Upon receiving consent to search, methamphetamine, marijuana (under 20 grams), and paraphernalia were found in the vehicle. D-1 was charged with the above narcotics and transported to the FCIF for processing.

Traffic Stop/92497-17/Palm Coast Parkway Palm Coast (Publix)/Sector 212 /Deputy Conway conducted a traffic stop and D-1 claimed to be a "traveler". D-1, provided a false name and did not have a valid driver's license. Upon LEO attempting to secure the subject, he was combative and displayed characteristics and statements of a sovereign citizen. D-1 was charged with providing false name while detained, Felony DWLS, resisting w/o violence, possession of a controlled substance, possession of marijuana under 20 grams, and possession of drug paraphernalia. D-1 was transported to the FCIF for processing.

Follow-up (recovered stolen vehicle)/92262-17/Oak Trails Blvd./Blyth Place, Palm Coast/Sector 216 /V1 advised that while he was driving around the neighborhood this morning looking to see if he can find his truck bearing license #PGM2P he spotted his truck parked at the intersection of Oak Trails Boulevard and Blyth Place on the grass. V1 then drove his truck to his residence and called the Flagler County Sheriff's Office. According to V1, nothing was stolen from the vehicle and it was not damaged. The vehicle will be removed from state and national databaes as stolen.
