Assist Public/ 17-92753/ James Roy Ave W, Palm Coast/ Sector 111 /Reporting Person (RP) called 911 to report that his shed was being burglarized. RP has previously called 911 to report that people are in his attic and people are traveling by water to burglarizing his house. Upon deputies arrival they found the shed boarded up, and the door padlocked from the outside. Deputies unlocked the door and tried to open it, but the items in the shed prevented the door from opening. It appears RP is starting to show signs of diminished mental capacity due to age. RP's daughter, who lives in NJ, was contacted and informed about this incident. RP appeared to be caring for himself and did not appear to meet Baker Act criteria. DCF notified. Stolen Vehicle- Recovered/ 17-92658/ Lysander Ln, Palm Coast/ Sector 214/RP advised that he allowed Other (O1) to borrow his vehicle to get to work, but when O1 woke up this morning the vehicle was missing from her friends driveway and the keys were gone from her purse. O1 advised that she stayed at Suspect's (S1) house and when O1 woke up, S1 and the vehicle were missing. The vehicle was later recovered at SunTrust bank. S1 stated that she was not involved in stealing the vehicle. Units reviewed video at SunTrust which shows S1 exiting the passenger side of the vehicle and an unknown female exiting the driver side, S1 was read her rights. Stolen Vehicle-Recovered/ 17-85832/ Carlson Ct, Palm Coast/ Sector 212 /Holly Hill Police Department responded to a Street in Daytona Beach and recovered the vehicle at that location, reference HHPD case #HH170003475.
