Vehicle keys and property from a stolen vehicle was located in Daytona at a park near Mason Avenue and Madison Avenue. Daytona responded and collected the items. Stolen Vehicle- Recovered/17-93022/ SR 100 E/ Sector 226 /Daytona Beach Police Department located a vehicle in their city abandoned. Daytona Beach Police Officer Houle advised that the vehicle appears drivable but has no tag or decal attached and no keys were found with the vehicle. The vehicle was removed from state and national databases, but the tag and decal remain entered stolen. See report by Deputy Jurec for further.

Burglary-Vehicle/ 17-93156/ Belle Terre Pkwy @ Whippoorwill Drive/ Sector 221 /RP advised an unknown person(s) by unknown means unlawfully entered his unlocked vehicle and stole numerous items between 12:00P-12:30P. RP advised that his vehicle became disabled at the above location and he left the vehicle unlocked and went to an auto parts store for a belt. Upon his return RP stated that his passenger side door was ajar and he noticed his GPS, unknown make or serial number, was missing.
