RP has previously called and reported people are in his attic, breaking into his shed and people are traveling by water to burglarizing his house. Upon deputies arrival no one was located outside the residence. It appears RP is starting to show signs of diminished mental capacity due to age. RP did not meet Baker Act criteria. Disturbance- Weapons/ 17-94908/ Florida Park Dr (Holland Park)/ Sector 212 /Female juvenile threatened juvenile male with a small pocket knife. Several witnesses corroborated this account in sworn statements. Knife was allegedly discarded prior to LEO arrival. Female juvenile was arrested and charged with aggravated assault. Deputy Dawson.

Missing Juvenile Recovered/ 17-94378/ Black Oak Ct./ Sector 216 /Deputy's Meehan and Dawson received information that M1 was staying at an address in the F section. Contact was made with M1 at that location and she was subsequently turned over to her mother. M1 was removed from state and national databases as missing by Flagler County Communications.

Baker Act/ 17-94927/ Blakeport Ln/ Sector 216 /Adult female baker acted.

Disturbance Physical/ 17-94879/ Langdon Dr/ Sector 213 /V1 reported S1 left the residence and asked V1 to watch three year old child. S1 returned to the residence and V1 could smell the odor of an alcoholic beverage coming from S1. S1 wanted to leave the residence with her child, which V1 objected to because of S1's drinking. S1 and S2 attacked V1. As a result of the altercation, V1 obtained a large abrasion to her left knee, a bite mark on her left forearm, a scratch on her right forearm, and a scratch her chest. S1 and S2 left the residence with the child unsecured in a vehicle. V1 wanted to pursue criminal charges against S1 and S2. 707 complete and turned over to night shift.
