Stolen Vehicle Recovered / 101470-17 / I95 MM 292/Sector 213 /Deputy Kocorowski located a stolen vehicle taken during a felony domestic battery from Miami. Deputy Kocorowski and trainee Deputy Barkoskie followed the vehicle on I95 NB from the 289 mile marker. Fireflight launched and a felony stop was conducted on Matanzas Woods Parkway and Luther Drive after the suspect exited the Matanzas Woods Parkway exit and was heading west towards US1. The driver and sole occupant stopped the vehicle upon marked units turning their lights on to initiate the stop. D-1, defendant, was read his Miranda Rights and responded by telling Law Enforcement he did not wish to speak. D-1 was transported to the FCIF for the charges of Grand theft auto, Poss of cannabis under 20, DWLS and Felony VOP.. Miami PD (Dispatch Operator Paucer ID #5519) confirmed with their units and advised they did not wish to have their vehicle processed.

Stolen Vehicle/2017-101368/ Fernmill Lane/Sector 211 /Vehicle was recovered in Volusia County at North Williamson Blvd. and Strickland Range Rd. It was being driven by a missing juvenile from case 100944-17 who was arrested by VCSO for grand theft auto and removed from state and national databases.
