Robbery Commercial/ 17-109552/Palm Coast Pkwy NE(Shell Harbor) / Sector 211

Flagler County Communications received information reference a robbery with a gun at this location, shortly thereafter a hold up alarm was received, units responded and set a perimeter. The clerk, V1, advised S1 entered the store and demanded the money from the register while pointing a firearm at her. V1 advised that she handed over a money and one pack of Newport 100's; S1 then fled on foot east bound on the parkway. The suspect was seen leaving the residence in a car and a felony stop was conducted on US 1 at the W 100 overpass. The subjects in the vehicle were transported to OPS for interviews a subsequent confession was obtained.

Burglary Residential/ 17-109588/ White Star Dr/ Sector 221

V1 and V2 advised that an unknown person(s) unlawfully entered their residence and stole multiple items including two firearms. V1 stated that the unknown subject(s) possibly gained access to the residence through a bedroom window.
