Fraud/ 17-111144/ SR 100 E (McDonalds 5) /Sector 226

RP advised that an unknown black female ordered a burger on the kiosk and payed at the counter using a \$100.00 bill. The female then left the store leaving her food behind. The RP then walked to the gas station and utilized their counterfeit pen which advised it was fake. The bill was collected and placed into evidence, still photos of the suspect were sent to Shannon for ATI.

Fraud/ 17-111165/ SR 100 E (Mobil 5)/ Sector 226

While investigating the fraud at McDonalds it was discovered the same unknown black female uttered a forged \$100.00 bill at the Mobil. The clerk advised that the bill was tested using their counterfeit pen which originally showed the bill was real, but the pen mark later turned brown indicating a counterfeit bill. The bill was collected and placed into evidence.

Fraud/ 17-111156/ Palm Coast Pkwy NE (Salsas)/ Sector 212

Black female ordered food and attempted to pay with a counterfeit \$100 bill. Female left before being confronted by staff. No witnesses saw the vehicle that the suspect was in. The description and MO match the other two incidents listed above. Management is going to burn a copy of the video and make it available at a later time. Dayshift was emailed asking them to check with the business for this video.
