Disturbance with Weapons/ 17-60577/ Parkview Dr (Frieda Zamba)/ Sector 225 /Two vehicles met in the parking lot and an argument ensued between the two drivers. One of the vehicles left the area at a high rate of speed. The driver of the other vehicle then fired two rounds in the direction of the vehicle as it left and then followed behind it in pursuit of the first vehicle. Both vehicles were last seen turning right onto Parkview Dr. One .380 round and one spent .380 shell casing were recovered on scene. A canvass of the area rendered negative results for the vehicles and no victim or suspect has been identified. Area hospitals were notified of the incident in case a victim shows up in an ER.
