The father and vehicle were found at Wal-Mart for interview where it was discovered that the incident was "organized." Charges for interference with child custody were completed against the father and resident of the home. DCF was also notified and a report was completed.</p> <p>Death/62670-17/Bud Hollow Drive Palm Coast/Sector 214 /A 17 year old male was found deceased with a gun laying next to him. Report made.</p>

Disturbance Domestic (missing endangered adult) / 62728-17 / Empire Ln, Palm Coast / Sector 226 / Victim (V1) reported that suspect (S1) became angry and grabbed V1 by the arm and slammed her against the wall. V1 was able to get free and fled next door where she called law enforcement. During the investigation V1 advised that S1 made suicidal comments. S1 left the scene in a vehicle prior to law enforcement arrival and was not located. Charges for felony battery by strangulation given to dayshift to attempt to make an arrest as well as a welfare check. S1 also entered into state and national databases as missing/endangered. Burglary-residential/62685-17/Flemingwood Lane, Palm Coast/Sector 212 /V1 advised she noticed her jewelry box was broken and items were missing from it on Saturday, July 23, 2017. There were no signs of forced entry into the residence and the home may have been left unsecured by her or a family member at some point. Report made.
