Part One UCR Crimes: Type of Call / Case Number / Address (Business Name) / Sector / Case Summary

Burglary/2017-71440/ Brian Ln, Palm Coast/Sector 214 /Victim (V1) called in and stated that a white male attempted to break into his residence. The suspect (S1) fled on foot and a perimeter was established in the surrounding area. The suspect was seen traveling on foot across the parkway and going into the Latino Market. Contact was made with the suspect inside. He was secured and a show up was conducted. V1 identified S1 as the suspect attempting to break into his residence. S1 was transported to ISD where he later confessed to two more burglaries. S1 was also connected to a call of a suspicious person that entered a vehicle without permission and requested the female drive him to the store. She complied until the male jumped out of the vehicle while it was slowing down. V2 did not wish to pursue criminal charges for this incident .See Deputy Shaughnessey's report for further details
