Traffic Stop / 2017-74436 / Forest Park Street / Arbor Avenue / Sector 312 /Dep Yeoman attempted a traffic stop on a pick-up truck at Forest Park Street and Arbor Avenue. Suspect vehicle did not stop and continued to Walnut Avenue. Dep Yeoman was able to read the tag of the truck and after a check it was found that the suspect vehicle was involved in a traffic stop on 8/25 with Dep J Williams and Dep Cochran. Dep J Williams responded as back up and saw the suspect vehicle traveling towards him on Walnut Avenue. When the suspect vehicle approached, Dep J Williams turned on his spot light illuminating the interior of the suspect vehicle where he was able to identify the driver as S1 from the contact he had with him on 8/25. Both units responded to S1's residence at 2313 Rosewood Street but could not locate S1 or the suspect vehicle.
