She was placed under arrest for no D/L and the other 2 passengers were asked to exit the vehicle so an inventory could be completed prior to towing. As the front passenger was exiting the vehicle, Dep. Alecrim saw a baggie with suspected cannabis on the floor, in plain view, between the seat and door frame. A search of the vehicle was then conducted with the following being found: 3 Blue Pills (1.1 grams suspected Ecstasy) and .5 grams of suspected "crack" cocaine and an additional 6.2 grams of suspected cocaine and 3.1 grams of cannabis were located under the passenger seat.
