<p>Burglary-Vehicle/75912-17/Blackfoot Court Palm Coast/Sector 216 /RP advised suspect(s) stole his wallet from his unlocked car. The wallet contained \$76.00 in cash, FL driver's license, two (2) credit cards, 2 ATM cards, and a debit card. The RP noticed several bank transactions on his account in the early morning hours from local Palm Coast stores. Video surveillance was obtained from Wal-Mart, showing all 3 b/m's who were positively identified by law enforcement using the stolen credit card and exiting the store. All three subjects arrested for burglary of an auto, fraudulent use of a credit card, tampering with evidence, and petit theft.</p>

Burglary-Vehicle (attempt)/75926-17/Blackberry Place Palm Coast/Sector 216 /The front passenger door was ajar, and upon further observation, the glove compartment was open and property was thrown throughout the vehicle. Nothing was stolen, report made.

Burglary Residential / 75969-17 / Underwood Trail, Palm Coast/Sector 224 /A generator was stolen a few days ago from the above address. The victim (RP) stated that his generator was stolen from his garage. Report made.

Larceny/75946-17/State Street Palm Coast (Pitts Glass)/RP checked his video surveillance this morning and observed the camera was sideways. The RP arrived at the business to review the camera and observed it was vandalized. Video footage showed the following: On 09/03/2017 at approximately 1735 hours, a male entered the rear side of the business through a bent gate. The male proceeds to the rear of the business, and takes possession of two 5 gallon gas tanks. The male then leaves the business, stealing the gas tanks. Shortly thereafter that an object strikes the camera, breaking the lens, however no one is observed breaking the camera. RP advised that there was damage to the metal siding, next to where the camera is placed, which he valued to be approximately \$1000.00 worth of damage. Report made.
