Baker Act	19-4526	Pheasant Ln	RP called dispatch and advised that her husband has been binge drinking and threatened to shoot himself. Units arrived on scene and were able to make phone contact with the male who stated he was not coming out and we could go inside. A small on-duty swat team and robotics were deployed. The mini team was able to get voice contact through the front door and ultimately made entry and found the male inside the residence unharmed. Male was secured and transported to Halifax for further medical treatment.
Follow-Up (Traffic Stop)	19-4448	Front St.	Reference this case from night shift, A follow up was conducted at 103 Front St., to attempt to take S1 into custody from the traffic stop she fled from last night. The male resident of the home allowed Deputies entry into the residence to look for S1. Upon clearing the upstairs portion of the home, an armoire was observed in a bedroom, with an item blocking one door of the armoire. Deputies opened the armoire door, and S1 leapt from the inside of the armoire and attempted to flee. Deputies were able to detain S1 and take her into custody without incident. S1 was placed under arrest for Flee and Elude LEO, Felony DWLS, Resist arrest without violence x2.
Assault-Battery (Simple)	19-4563	Ripley Pl.	S1 and V1 were involved in a physical altercation. S1 reportedly punched V1 in the face, causing him to fall back onto the ground, then kicked V1 in the face while he was on the ground. 2 independent witnesses confirmed Angel to be the primary aggressor. S1 was arrested reference simple battery, and transported to FCIF.
Baker Act	19-4568	Belle Terre Pkwy (WES)	Juvenile placed under a BA and transported by patrol to HBS.
Baker Act	19-4562	5500 SR 100 (FPC)	Juvenile placed under a BA and transported by Patrol to HBS.
Criminal Mischief	19-4559	Justice Lane (FCIF)	S1 wrapped a bed sheet around the fire sprinkler system in his holding cell causing it to break. The breaking of the sprinkler head caused water to flow into the cell and the fire suppression system had to be shut down to make repairs. S1 was charged with damaging or preventing the use of fire equipment.
Criminal Mischief	19-4471	Forest Park St	RP advised an unknown person(s) slashed two (2) tires on her parked 2013 Chevy Malibu bearing Florida tag 4932TW overnight. RP does not have any cameras on her residence and does not know who would do this.
