Death	20- 10110201	Kalorama Ct	O1 located his wife, O2, deceased in her bedroom. CPR was attempted however signs of death were obvious upon LEO and Fire / Rescue's arrival. No known medical history. No foul play was suspected. Report by Deputy Ocampo.
Assault / Battery (Delayed)	20-110223	Bannbury Ln	Two parties were involved in a dispute at approximately 0100 hours. The two are roommates and started arguing about an unwanted guest in the residence. O1 alleged that O2 battered her. O2 stated that O1 was overly upset about O2 having her boyfriend in the residence, and that she tried to calm her down by grabbing her by the arm. No injuries were reported or observed. Charges for simple battery were forwarded to the SAO on O1's request.
Disturbance Physical	20-110261	Ulaturn Trl	Physical disturbance between roommates. O1 refused to give back O2's property until he paid his back rent. During the argument, Robinson stated that O2 pushed and choked her, holding her over a bannister by her neck. O2 stated that O1 hit him with a glass bottle. After collecting statements, and reviewing the 9-1-1 audio, it was determined that probable cause existed that O2 did unlawfully touch / strike / O1 against her will, and was placed under arrest for simple battery. Upon search incident to lawful arrest, O2 was found to be in possession of narcotics, and additionally charged with two (2) counts of possession of controlled substance. Report by Deputy D.
