Burglary Attempt	21-16511	Old Kings Road South (Bulow Plantation Resort)	V1 reported he came back to his cabin to find that an unknown person broke the door. The only thing keeping the door secure was the lower door handle lock. Nothing was found to be missing from the interior of the cabin.
Domestic Disturbance	21-16495	US1 and Matanzas Woods Parkway	S1 was placed under arrest for DV Battery after an altercation on Matanzas Woods Parkway. V1 flagged down Deputies and advised that S1 grabbed her by the neck (did not restrict breathing) at her residence after an argument. They both left the residence in same vehicle and the argument continued. S1 ultimately exited the vehicle and was located walking North on US1.
Death	21-16530	Pony Lane	Family discovered V1 deceased in his bedroom.
Domestic Disturbance	21-16497	Bunker Knolls Drive	S1 was placed under arrest for DV battery and DV strangulation after having a disturbance with family. V1 advised that S1 grabbed him by the throat restricting his breathing and slapped him in the face after a verbal argument. V1 had injuries consistent with his statement. After being arrested, S1 complained of medical issues and rescue responded to assist.
**Battery on EMT	21-16524	Bunker Knolls Drive	While rescue was attempting to assist getting S1 transported to Advent Health for medical clearance, he became belligerent and hostile towards all first responders. S1 intentionally kicked a Flagler County Paramedic in the shoulder. No injuries.
Baker Act	21-16501	Lemay Place	Adult female placed under Baker Act.
Disturbance Physical	21-16544	Elder Street	S1 was arrested for battery by strangulation (domestic) after an argument that became physical with his girlfriend, who he lives together with as a family.
