Stolen Vehicle Recovered	21-35587	Evanson Lane	Vehicle (Black Honda Accord FL PYN U22) previously entered as stolen by the registered owner, has been located at Cube Smart. Vehicle was not damaged and was turned over to the owner. The vehicle was removed from FCIC/NCIC. Video surveillance of the suspect driving and leaving vehicle in the parking lot was captured. Charges are pending against the suspects.
Shoplifter	21-35804	Palm Coast Pkwy	Employee, S1, was caught shoplifting by loss prevention agent. S1 was detained and charged for retail theft. During a search incident to lawful arrest, a small amount of cocaine was located on her purse.
Shoplifter	21-35813	Cypress Point Pkwy (Wal-Mart)	S1 was an employee who was taken into custody for shoplifting. A charging affidavit was completed for submittal to the SAO. Written statements and a copy of the surveillance video were provided by the complainant.
Death	21-35815	Cherrytree Court	The reporting party advised he went to the residence to check on his father and found him deceased inside.
Animal Bite	21-35831	Pickering Drive	A female was bit by a loose pit bull. Animal control responded and took possession of the animal.
Disturbance Domestic	21-35826	Burning Bush Drive	RP called 911 to report that her daughter, V1, had been struck in the face by her boyfriend, S1. Contact made with victim at the residence who had facial injuries, including swelling to the eye, cheek and lip. S1 left the residence prior to LEO's arrival. His vehicle was entered into the hot list, a BOLO was issued out to surrounding counties, and a charging affidavit was handed to night shift should they be able locate S1.
Violation of Injunction	21-35621	Farrington Lane	S1 was taken into custody after she was on scene at this location. This was a violation of a no contact order (related to domestic violence) against the victim.
BOLO	21-35833	US-1 and the South County	VCSO advised they had felony criminal mischief and fleeing and eluding charges on a blue Toyota FL bearing a Florida License Plate of "IH52JZ" last seen entering Flagler County. FFLT was launched. Deputy Denker located the vehicle on Old Dixie Highway which fled upon seeing law enforcement. Deputy Dank attempted to stop the vehicle through the use of his lights and sirens, however did not pursue the vehicle upon observing it flee. Deputy Strack successfully deployed stop sticks on the vehicle in Bunnell. S1 fled from the vehicle on Deen Road. During a foot pursuit, Deputy Denker successfully deployed his Dart Firing Stun Gun, and gained S1's compliance. S1 was arrested for fleeing and eluding, and resisting without violence. The Ormond Beach Police Department

responded to the Flagler County Inmate Facility and served S1 with their charges against him.
