Burglary Vehicle	19-40883	Ryecroft Lane (taken at PCDO)	RP stated his wallet was stolen from the center console of his girlfriend's vehicle overnight.

Suicide Threat (Warrant Service)	19-41206	Rosewood Street and Canal Avenue	S1 was driving a white pickup truck in the area and was suicidal and was armed with a handgun. Sergeant Weaver and Deputy Strack/FTO Lichty located the vehicle on Mahogany Boulevard which fled. The vehicle was not pursued as Deputies attempted to maintain a visual of it but lost visual as FFLT was launched. The vehicle was located crashed, abandoned, on Blueberry Street and a perimeter was established. S1 was apprehended in the woods by a K9 bite of his right shoulder by Corporal Tarczewski's partner. S1 showed Deputy Lichty where the gun was at in the woods and it was recovered, along with an ejected round. S1 was charged with his three felony warrants, aggravated fleeing and eluding, felony driving while license suspended and resisting without violence. A Baker Act form was completed and left at the Green Roof Inn.
