Baker Act	19-74191	SR 100 (McDonalds)	A adult male was placed under a Baker Act.
Domestic Disturbance	19-74175	Pine Hurst Lane	Deputies responded to address after reports of a physical disturbance. Contact was made with both parties who gave conflicting stories and the male half agreed to leave the residence. DCF was notified due to a child being at the residence. Both subject's refused to complete written statements. No injuries observed. See report by Dep. Quintieri.
Death	19-74240	Fulton Place	RP reported that his wife passed away. Nothing suspicious observed. See report by Dep. Held.
Follow-up	19-74014	Buffalo Meadow	A follow-up was conducted in reference to the welfare check from yesterday. Deputies assisted DCF with making contact with O1 at the residence. O1 allowed us to enter the residence and check all bedrooms inside. It appears that O1 rents out individual bedrooms upstairs and that is why each room has its own deadbolt. Contact was made with an adult in one of the rooms, who is in good health. Contact was also made with O1's wife and 16-year-old stepdaughter. DCF completed its investigation and Sgt. Breckwoldt completed a supplement report.
Fraud	19-74254	Fredrick Farm Road	Dispatch received several calls from citizens who stated they received phone calls from a person who identified themselves as a member of the Flagler County Sheriff's Office. V1 received one of those calls and fell victim to their scheme to defraud. The person told V1 that she had a warrant for her arrest because she did not appear for jury duty. If she did not comply with the caller's instructions, she would be arrested immediately. V1 stated that the subject said to bring an envelope and stamp to the sheriff's office "kiosk". V1 then obtained Eight Hundred (\$800.00) dollars. While driving into town, she was instructed by the subject to go to CVS and obtain two (2) Green Dot Money Pak Cards in separate amounts (\$425.00 and \$375.00) and travel to the Flagler County Sheriff's Office (901 E Moody Blvd, Bunnell, Florida) which is permanently closed to the public and law enforcement, and sign her paperwork.

Prior to her arrival at the Sheriff's office, V1 stated that the subject asked to scratch the numbers off of the cards and provide them to him over the phone, which she proceeded to do. V1 then was told to place the cards into an envelope and mail them to "Nation Bond, 501 W. Adams St. Jacksonville, Florida, 32446". V1 stated that when she arrived at the Sheriff's Office, another subject got on the phone stating he was "Sergeant Cooper", and advised V1 that one of the cards did not go through and if she was to enter the building she would be placed under arrest. V1 at this time the hung up the phone and contacted the Flagler County Sheriff's Office non-emergency line and was informed she was being scammed. Commander Stuart was notified, and he contacted the FCSO PAO to issue a release warning the Flagler County residents of this scam.
