18-80891	Grand Theft-Shoplifting	S.R. 100 Target	S1 Selected a Dyson Vacuum valued at \$499.99 from the shelf, removed the secured device and left without paying for it. S1 was stopped by Loss Prevention and taken into custody. He was arrested for Grand Theft . A week prior S1 also came in and stole the same vacuum. S1 was charged for a second Grand Theft under case#2018-80956
18-80945	Burglary from Vehicle	Old Kings Road South All State	V1 reported that Between 1315 and 1630 hours someone smashed out the rear passenger side window and stole a lunchbox.
18-80879	Disturbance-Physical	Felter Lane	S1 walked into V1 office demanding an apology, when she didn't receive one, she struck V1 3 times against her will. S1 was taken into custody for the battery, in her purse there was a plastic container, containing a white crystal which field tested for cocaine. S1 was transported to the inmate facility.
