Warrant Attempt	20-72081	First Avenue	S1 had an active warrant out of Orange County. S1 physically resisted the Deputies attempt to secure him and was tased. However, it was ineffective. Before any further escalation S1 was convinced to surrender peacefully and was secured without further incident. See Report by Deputy Douglas
