18-72806	Disturbance Physical	Cardinal Lane	V1 stated that he went to S1 residence to look for his girlfriend. V1 stated S1 came outside and pushed him to the ground and hit him with his bicycle. V1 statement changed several times and S1 denied the allegations. A charging affidavit for battery will be submitted to the SAO for review.

A check of the VIN number on the vehicle revealed an expired Florida registration from 2011, but the registered owner insisted the vehicle was currently registered into FCIC/NCIC as stolen.

S1, sole occupant and registered owner, was placed under arrest reference to Poss of Marijuana Over 20 grams.

The vehicle was removed from the scene by Rogers Towing.
18-72922	Narcotics	CR 13 and US 1	Deputy conducted a traffic stop on a vehicle for speeding. Upon making contact with the driver, Deputy could smell an odor of marijuana from inside the vehicle. During the probable cause search a loaded Smith & Wesson .45 handgun was found under the front passenger seat along with 1.6g of cocaine. The firearm was

reported stolen out of Flagler County on 4/29/18 (2018-39640). The driver stated she observed the front passenger S1, bring the handgun into the vehicle. The juvenile was placed under arrest for possession of cocaine, grand theft, and possession of a firearm by a minor. The firearm was removed from NCIC/FCIC as stolen.
