O1 stated while breaking it up, O2 punched him. O2 said while he was breaking it up, O1 pulled her by the hair. O1 then returned to his home in the Z section. Parties refused to write sworn statements, or sign complaint affidavits. The children were left with O2 and O1 was at his residence, so there was no chance for further altercations. It appears the only "domestic" battery occurred due to Joseph breaking up a non "domestic" disturbance.

V1 told deputies that she and S1 were hanging out having a good time, then she woke up bleeding from the back of the head. She advised she doesn't know what happened. S1 stated that V1 got mad and tried pushing him, but she fell and hit her head. We went back and reviewed the 911 call and V1 told dispatch that S1 pushed her and she hit the table. When asked about this info, V1 stated she doesn't want him to go to jail. She then stated she doesn't know what happened. S1 was arrested for Battery Domestic.
