Domestic Disturbance	<b>18-110798</b>	N. Oceanshore Blvd	S1 went to V1 apartment to talk to him (they have a child together). V1 would not let her in so she began to bang on the doors and windows causing a window to break. S1 is on misdemeanor probation for violation of pre trail release and part of her probation is to have no violent contact with Robert. While at FHF S1, made comments that she wanted to harm herself. A Baker Act form was left with FHF staff and misdemeanor VOP and criminal mischief charges will be forwarded to the SAO.
Domestic Disturbance -Physical	<b>18-110750</b>	Biltmore Pl	O1 called to advise her son S1 was intoxicated and had struck his father in the head and face multiple times. While Deputies were on scene it was determined S1 met Baker Act criteria. While attempting to place S1 into the rear of the patrol vehicle, he became combative and slipped out of one of his handcuffs. S1 then attempted to jerk away from Deputies and punched a Deputy in the face. S1 was taken to the ground and re-secured in handcuffs. S1 was charged with Battery DV, Battery on LEO, Resisting with violence.
Baker Act	<b>18-110762</b>	Pine Lakes Parkway	Female was placed under a Baker Act.
Domestic Disturbance -Physical	<b>18-110796</b>	Radcliffe Dr	RP called to advise her husband S1 had kicked her out of the house after a verbal altercation reference marital issues. Initially the RP was reluctant to admit a physical altercation had taken place. Through investigation it was learned that S1 had struck his wife in the face multiple times and picked her up and threw her out the front door of the residence before locking her out. Statements collected and DV paperwork given to victim. S1 arrested reference DV battery.
Domestic Disturbance -Physical	<b>18-110764</b>	Bird of Paradise Dr	O1 called and advised her daughter's boyfriend S1 had punched her husband V1 in the face. Upon arrival, S1 was no longer on scene. At V1s own admittance, he was the primary aggressor so no charges were filed.
Domestic Disturbance -Physical	<b>18-110430</b>	Zodiacal Pl	S1 admitted to slapping v1 and was subsequently arrested for Battery DV.

Narcotics	<b>18-110708</b>	Hickory Street and Fruitwood Ave	fcso conducted a traffic stop on s1 for riding a bicycle with not lights. S1 gave consent for a search and methamphetamine and drug paraphernalia was found, s1 was placed under arrest.
