18-33892	Domestic Disturbance	Beechwood Lane	V1 stated S1 came home to and they engaged in a verbal confrontation in the driveway, which then escalated into a physical altercation. During which, S1 scratched the V1 about the neck and chest area. V1 then punched S1 in the face to defend herself. S1 was placed under arrest for domestic battery as she was the primary aggressor.
18-33942	Larceny	Beachway Drive	V1 advised he came home to have lunch around 1245 hours and realized his kayak was missing.
18-33916	Domestic Disturbance	Slumber Path	V1 stated as he was exiting his vehicle, he turned his body towards the driver side door (which was open) and placed his feet on the ground to get out. V1 stated S1 "slammed the door closed on his legs." V1 complied with providing a sworn written statement, but stated he did not wish to pursue criminal charges against S1. Parties separated and charges for domestic battery forwarded to the SAO.
18-33981	Traffic Stop	Whiteview Pkwy & Ravenwood Drive	Deputies conducted a traffic stop on a vehicle. Contact was made with the driver, S1. Deputies were able to identify S1 through his DAVID photo. Deputies asked S1 to shut the vehicle off and get out. S1 then placed his vehicle in gear and fled from Deputies on scene. No pursuit was initiated as S1 had been identified and was driving at a high rate of speed. Units searched for the suspect vehicle but were unable to locate. Charges for fleeing and eluding will be submitted to the SAO for review.
18-33982	Crash	Old Kings Road south of Oak Trails Blvd	A truck collided with a guard rail. The truck rolled over and struck a large metal water pipe. S1 claimed someone unknown to him was driving his truck and ran. A witness that was behind him was able to identify S1 as the sole occupant and driver of the truck. S1 was placed under arrest and charged with DUI w/property damage.
18-33983	Assist Other Agency	Gunby BLVD	FCSO units responded to the city of Bunnell Police Office who requested back up after disrupting a burglary in progress. Bunnell officers chased a suspect, wearing all black, on foot before losing sight. Deputies spotted the male but were not able to apprehend him. The male was never located.
