Disturbance Physical-Domestic (Delayed)	<b>19-43621</b>	Seville Pl	V1 (Victim) and her ex-boyfriend (Suspect) S1 have resided in the residence as a family unit. V1 reported that on 5-9-19, she and S1 were involved in a verbal argument reference relationship issues. S1 placed his hands around V1's throat restricting her breathing. S1 pushed her into a wall, causing bruising to her arm, back, and buttock area. S1 then pushed V1 into a corner and refused to allow her to leave, restricting her movement. V1 was able to get S1 to back away by hitting him with a metal bowl. S1 left the residence at that time and advised he was staying at a hotel in Daytona Beach. An attempt to contact TTY was send to DBPD but met with negative results. A charging affidavit was completed on S1 reference Battery by Strangulation and False Imprisonment.
Domestic Disturbance	<b>19-43520</b>	Hickory St	V1 advised that her live-in boyfriend S1 of three (3) years arrived at the above location and began attacking her. V1 stated that S1 punched and kicked her along with hitting her in the neck with a broken handle of a metal shovel. V1 attempted to get away numerous times, but S1 continually threw items at her. S1 was not on scene and was unable to be located.
