Disturbance -Physical	19-44165	Pine Lakes Pkwy @ Palm Coast Pkwy	Multiple callers called advising a male and female were involved in a physical disturbance while driving on Palm Coast Pkwy. The male was driving a blue Hyundai, and stopped the vehicle. The female, exited the vehicle. The RP stated the female was crying and appeared upset, when the male picked her up and carried her back to the car. Units were looking for the vehicle, when Deputies located it disabled and unoccupied in a ditch at the intersection of Hargrove Grade and Industry Dr. Deputies observed a male matching the description of the suspect, crouched down hiding behind the dumpster in front of 3 Industry Dr. Upon the sight of LE, S1 fled on foot west into the woods. A perimeter was established and the male eventually exited the woods and was taken into custody. He advised he was in a verbal altercation with V1 and nothing physical occurred. Contact was made with V1 reference a well-being check and she advised she did not know what LE was referring to and became uncooperative. V1 had no visible injuries and refused to cooperate with the investigation. David was placed under arrest reference resisting w/o violence.

Larceny- Shoplifting	19-44186	5151 Belle Terre Pkwy (CVS)	CVS management stated a juvenile female was in the business taking food and drink items from the shelf and consuming them inside of the store. When confronted by the employees, she was asked if she was going to pay for the items, and she advised she was not. The juvenile then began yelling and screaming inside of the store, causing management and other patrons to take notice. Upon arrival of Deputies, S1 was taken into custody and placed under arrest for retail theft-petit and Disorderly conduct. DJJ accepted S1 for intake, and she was transported to DJJ. VOP	19-44216	5151 Belle Terre Pkwy (CVS)	Reference 19-44186, it was determined S1 was currently on probation and had a 7PM curfew. Due to S1 being in violation of her curfew, she was also arrested reference the VOP. Report by D/S Wallis

Physical Disturbance	19-44192	Flamingo Dr	RP called to advise his roommate (S1) and he were involved in a physical disturbance. RP stated S1 got angry and began striking him in the face multiple times with a crutch. S1 then began striking RP in the face and head multiple times with a closed fist. RP had a laceration to his nose and multiple bruises and areas of redness. S1 denied any physical altercation occurred. An independent witness on scene confirmed RP's allegations, and provided a sworn written statement. RP was transported to Advent Health by FCFR. S1 was arrested reference Agg. Batt. And transported to the inmate facility. Report by D/S Oldham.
Narcotics	19-44212	Water Oak Road and Mahogany Blvd	Deputy Beausole conducted a traffic stop on a red Dodge pickup for a traffic violation. After issuing the driver, S1, a UTC he gave consent to search the vehicle. During the search, he located a small clear plastic bag with a white substance that tested positive for cocaine. S1 was placed under arrest for possession of cocaine. See report by Deputy Beausole for further.
Assault and Battery	19-44235	Walnut Ave	V1 (victim) reported that she was spending the night with her ex-boyfriend when she went to sleep and left her wallet on the back porch on the table. At some point, she woke up and checked her wallet to discover that \$2,000 U.S. currency from her tax refund was missing. She then confronted S1 (suspect), a resident of the home, about the missing money. V1 advised that a heated verbal altercation broke out between the two, which eventually led to S1 "attacking her." Attempt to make contact with S1 to obtain her side of the story was met with negative results. A follow up will be conducted with S1 before any charges are signed.
