Brush Fire	20-48050	Flagler Plaza Drive (Winn- Dixie)	Multiple reports of large amount of smoke behind the Flagler Plaza Business Center. Active brush fire in woods and forestry responded with tractor due to heavily wooded area. Deputies responded due to hotels/businesses in area. Due to fire location, no evacuations were necessary. TOT fire department.
BOLO	20-48078	I-95 #296 Southbound	JSO reported that a stolen 2012 Kia was southbound on I-95 and fled from St. Johns County. Deputies located the vehicle at the southbound weigh station and attempted a traffic stop. The vehicle continued southbound while fleeing and eluding. Pursuit not authorized; stop sticks were set up at SR 100 off ramp. Vehicle continued southbound without incident. FHP and Volusia County SO notified. PACE completed charges
Death	20-47989	Palm Coast Parkway SW (Winn Dixie)	Relieved dayshift. Medical Examiner arrived on scene and removed body.
Disturbance Weapons	20-48036	Belle Terre Parkway and Palm Coast Parkway	V1 reported that a black male in another vehicle pointed a firearm at him after he confronted him about his driving at a traffic light. V1 stated the male was driving a red explorer recklessly on Palm Coast Parkway. He then pulled up to him at a red traffic light and asked what his deal was. The male then pointed the firearm at him and his wife before driving away. V1 followed the vehicle until it turned on Pine Grove Drive. Cpl. Meehan located the vehicle at 44 Pine Tree Drive. Contact was made with S1 who answered the door. S1 admitted to a road rage incident and brandishing a black colored BB gun. The BB gun was located in plain view on the passenger seat of his vehicle. Both victim's refused to press charges although it was explained to them the seriousness of the incident. The BB gun was placed into evidence. Report made by Dep. Beane. Supplement made by Dep. Schmidt. No charges at this time.
