Disturbance w/ weapons	20-43676	Palm Coast Pkwy SW (Wells Fargo)	Deputies made contact with the RP who advised she was at the ATM and a male said "I'll shoot everybody". The other party was located at the Kangaroo on Kingswood Dr. The subject advised he was at the ATM machine at the above location and a female exited her vehicle complaining the male was taking so long and she sparked a taser. Neither party wished to provide any further information and all parties left the area.
Domestic Disturbance	20-43716	Paul Ln	Anonymous caller advised he heard subjects screaming from behind his residence. During the investigation, it was learned that the female, S1, had an active warrant for her arrest reference VOP out of Highlands County FL and S1 was placed under arrest reference the warrant.
Suspicious Vehicle-Narcotics	20-43727	Kingswood Dr. (Red Roof Inn)	FCSO checked out with an occupied vehicle in the parking lot of the hotel and observed the subjects in the vehicle smoking marijuana. After making contact with the subjects, a probable cause search of the vehicle revealed marijuana, methamphetamine, cocaine, crack cocaine, a scale, and paraphernalia. The driver S1 was arrested reference possession of methamphetamine. The passenger S2 was arrested reference possess methamphetamine, possess marijuana < 20 g., possess cocaine w/ intent to sell, possess paraphernalia.
Narcotics	20-43736	Palm Harbor Pkwy @ Cimmaron Dr	Deputies responded to this location reference 3rd party information of a female on scene who appeared under the influence and was claiming her boyfriend just hit her. Upon arrival, the female was obviously impaired and acting very erratic. A consensual search of her vehicle revealed 7 Buprenorphine (Subutex) and a loaded syringe, as well as other paraphernalia. S1 was arrested reference possess SCH II and possess paraphernalia.
Narcotics	20-43766	I-95 SB MM281	Deputies made contact with a male skateboarding SB on the shoulder of I-95 at this location. The male was found to be in possession of a clear plastic baggy containing synthetic cathinones. S1 was arrested reference possession of cathinones, , possess cocaine, possess paraphernalia.
Physical Disturbance with Weapons	20-43750	Potatoville Road (Flagler Estates)	RP called in a truck in a ditch and multiple subjects fighting. RP reported seeing gunshots (tracer rounds) but advised he did not witness any person shooting a firearm. During the altercation an assault rifle was seen on the hood of a dark colored Ford Ranger. The subjects involved in the fight fled in the Ranger along with a Yukon which were able to be stopped and the occupants identified. During a high risk traffic stop a vehicle pulled up on law enforcement and a passenger was identified as being a victim with a possible gunshot wound to his chin (non life threatening) victim was transported to Putnam County hospital ****Call still active*****
