18-65915	Larceny	Palm Coast Parkway (Circle K)	O1 advised that she was sitting outside in front of the store smoking a cigarette with S1. S1 gave her some money and asked her to go into the store to buy him a Black and Mild brand cigar. At this time O1 entered the store and left her cigarettes and cell phone outside next to New York. When she exited the store S1, her cell phone, and cigarettes were gone.
18- 65920	Domestic Disturbance	Madison Green Circle	V1 advised that her husband, S1, was intoxicated. V1 further advised that S1 turned off her electric wheel chair, stood in front of her in an imposing manner, and placed his hands on her face. V1 advised that she was afraid that S1 was going to cause her harm as he was standing over her. V1 then advised that S1 then placed one of his hands around her throat, without impeding her airway, and explained to her that he has killed people and that he kills people. S1 was placed under arrest and charged with abuse of a disabled person, domestic assault and resisting without violence.
18-65908	Welfare Check	Pine Lakes Pkwy Apt. 815	O1 lives out of state and received a text from her husband, O2 at approximately 8:30 pm threatening suicide. Units responded to his residence but did not locate him. DBPD later made contact with him at the Hilton Express and advised he was ok and did not meet Baker Act Criteria.
18-65857	Warrant Service		FCSO located S1 walking down Tangerine Avenue near Water Oak Road and she was arrested for her outstanding burglary warrant. S1 was additionally charged with possession of methamphetamine, possession of cannabis under 20 grams, possession of legend drug x 2 and possession of drug paraphernalia.
18-65870	Reckless Driver	Chapel Street	Deputies attempted a traffic stop on the vehicle on US1 which fled Southbound on US1. The vehicle was not pursued as deputies attempted to deploy stop sticks on US1 with negative results. The vehicle was last seen Southbound US1 near Old Dixie Highway.
