18-68912	Larceny Shoplifting	Palm Coast Pkwy (Kohls)	O1 stated he watched the female, later identified by her Volusia county inmate photo as S1, roam around the store and gather several items and place them into a mesh Kohls shopping bag. S1 then went towards the store exit passing all points of sale on the men's side and at this point O1 identified himself as loss prevention and informed S1 she was being detained, S1 then ran past O1 to a red and black vehicle waiting outside of the door. O1 took a picture of the tag, Florida tag 1391XV, and the vehicle came back S1 out of Ormond Beach. Charges for grand theft and resisting a merchant forwarded to the SAO.
18-68962	Robbery Person	Old Kings Road (Shell Gas Station)	V1 stated S1 battered her and stole her money. V1 stated she met S1 at the Shell gas station, located at 5 North Old Kings Road so V1 could pay S1 fifteen dollars (\$15.00) for gas money she owed her. V1 gave S1 the money and then got into her vehicle to leave. S1 then reached in through the vehicles window and snatched the waitressing tab, containing ninety dollars (\$90.00), from V1s hands inside the vehicle and ran off. V1 then exited her vehicle and ran after S1. V1 caught up to S1 at her vehicle and a physical altercation ensued when she tried to get her money back. During the altercation S1 punched V1 in the head and she fell to the ground. V1 provided a description and tag number for the vehicle S1 left the scene in. Contact was made with S1 at the registered owner's address. S1 was arrested and charged with Robbery by sudden snatching, petit theft and battery.
18-68907	Larceny	Rymfire Drive (Ralph Carter Park)	V1 stated that the bicycle he had been riding while visiting his family was taken by two black males he did not know and they rode it to the rear of the park before jumping over the fence with the bicycle and leaving. The bicycle was described as a red and black "Next" brand mountain bike that is missing its left pedal worth \$40.00 dollars.
