18-75043	Robbery Commercial	E State Road 100 #105 (Kay Jewelers)	Deputies responded to the jewelry store for a commercial alarm where the clerk advised she had just been robbed. Both males were described to be in their 20's, 5'8" - 5'9" tall. Once the male in the gray shirt failed to forcefully take possession of the keys, he proceeded to remove a small sledgehammer from his shorts pocket and approach the gold case. The male then began to strike the front of the case which is made of tempered glass. The male continued to hit the glass case until he was able to reach his hand inside of the case and remove numerous gold chains and bracelets. Once the male removed the items from the case, he and the male in blue fled the business on foot westbound towards Target. Perimeter set and air support and K9 responded but the suspects were not located.
