Aircraft Incident	20-89077	Chelsea Ct	While VCISO Air one was attempting to locate a fleeing felon on 20-89061, the pilots advised there was a male on the pool deck of the above address shining a green laser at them. Units arrived and arrested S1
Traffic Stop	20-89061	Old Kings Rd @ Frontier Dr	Cpl. Myers conducted a traffic stop on a vehicle at this location. The driver S1, fled the scene. S1 vehicle was spotted in the Sabal Palms Assisted living parking lot, still running and unoccupied. A perimeter was established and Air One and K-9 responded to assist. Air One was able to locate the driver, hiding in the woods nearby, where he was taken into custody without incident.
Traffic Stop	20-89037	Old Kings Rd @ Forrester Pl	Deputy attempted a traffic stop on a Toyota Rav 4 at this location. S1 refused to stop and fled the stop. S1 was unable to be located. A charging affidavit was completed on Stoops reference Flee and Elude, Resisting w/o violence, possession of drug paraphernalia, DWLS w/ knowledge, and Felony VOP.
Baker Act	20-89026	Kalso Ct	Juvenile placed under a BA and transported to Halifax.
Larceny-Grand Theft	20-89052	White Haven Ln	Victim advised she was allowing S1 to stay at her residence. She has not seen S1, and has noticed appx. \$948 in jewelry and miscellaneous items missing from within her residence.
Domestic Disturbance-Physical	20-89078	Bulldog Dr	Victim stated S1 came to the door of the apartment. When she began to open the door, S1 forced his way into the apartment and forcefully grabbed both of her arms and "slammed" her against the wall. A charging affidavit was completed on S1 reference Felony DV battery on a pregnant person.
Missing Person-Found	20-88948	Winchester Rd	Missing Person-Found/ 20-88948/ 11:00P/ Winchester Rd/ Sector 314 M1 was located at her house, while conducting a follow up. M1 was removed from NCIC/FCIC by Flagler County Communications.
Domestic Violence	20-89053	Carver St	V1 advised that S1 pushed her down, slammed her head into the wall of their bedroom and threatened her with a knife. S1 was later located and arrested for DV batt and assault.
Traffic Stop	20-88991	Old Kings Rd @ Oak Trails Blvd	Traffic stop was conducted and S1 was arrested for two local VOP felony warrants. A probable cause search revealed multiple palmetto berries in the back seat. S2 advised that he had picked them and he did not have a permit to do so. Deputy advised S2 he was under arrest. S2 immediately fled on foot. Deputy had a successful Taser deployment however S2s momentum caused a probe to come out and he continued to flee. K9 Deputy Cavas was able to apprehend him and S2 was charged with unauthorized possession of an exploited plant and resisting arrest without violence.
