Robbery	2018-91910	Palm Coast Pwy Pet Supermarket	The business had just closed, one employee had just left and two remained inside. Minutes later someone pulled on the door, assuming it was the employee that just left, they unlocked the door. Once they realized it was not the employee, they try to pull the door close, but couldn't. The subject enters and hands one employee a note and was carrying a handgun. The subject then left with an unknown amount of money. District Manager was called in to access video surveillance.
Burglary Residential	2018-91930	Fellowship Lane	Between 10 am and 1030pm someone pried open the rear slider and entered the home. They rummaged through a night stand and 2 closets in the master and a cabinet in the master bath. The only thing missing there was a purse with unknown contents. In a guest room they took \$600, an ID, bank card and social security card from a purse. They do not have any video surveillance. It didn't appear any of the neighbors had surveillance either, but it was too late to knock and see if anything was observed.
Burglary Vehicle	2018-91970	Richardson Dr	V1 came out to leave his friend's house at about 0500 and discovered someone had been in his unlocked car. They went back and reviewed video surveillance from the house and you can see an image (no vehicles) wearing a "hoodie" enter the car around 0204am. Stolen was a credit card and condoms. The condoms were located the next street over on Richelieu Lane. The video was too far from the car (parked in swale) to make out the image well. Vehicle was processed as well as the found condoms. Credit card was cancelled and neighborhood checked.
Disturbance Domestic	2018-91933	Barrington Dr	V1 and her S1 got into an argument when S1 returned home and woke her up. S1 then slapped V1 on her arm and knocked the phone from her hand when she called 911. S1 then left the home with their 2 children to go to his father's house. S1 was located and he refused to write a statement or let his kids write one. S1 was arrested for domestic battery.
Disturbance Domestic	2018-91929	US 1 South	S1, slammed V1, on the ground and then slammed her head onto the ground several times during an argument. V1 was transported to Florida Hospital Ormond by her mother. Law enforcement responded to FHO to obtain a statement and document V1's injuries. V1 has a large bruise and swelling on her forehead

			consistent with her statements. S1 was unable to be located at his residence and a charging affidavit will be turned over to dayshift. An email was sent to ISD in reference to obtaining a warrant Monday if the subject is not located.

S1, struck V1, in the jaw with a small miracan style bat during an altercation at S1's residence. O1, also had injuries consistent with being battered also but she adamantly denied a physical altercation. V1 stated she struck her head on the chicken coop at her residence but the injuries were not consistent with her statements. O1 was questioned multiple times about the incident and deputies were unable to determine probable cause a domestic battery took place between S1 and O1 therefore an arrest could not be made. O1 was offered all domestic violence services out of precaution and she declined all services. A domestic violence packet was provided to her for future reference. V1 also refused to cooperate with the investigation and refused to provide a statement or pursue charges against S1 for simple battery. O1 agreed to separate from S1 for the evening.
