Joint Agency Efforts Take Down Drug House

On March 29th, the Flagler County Sheriff's Office Special Investigations Unit (SIU), FCSO Tactical Team, and Flagler Beach Police Department executed a Search Warrant at 135 Oak Lane in Flagler Beach following a 2-month long investigation by SIU and the Flagler Beach Police Department.

The residence has been the focus of multiple complaints of heavy traffic and suspected drug activity. The investigation led to a search warrant that was executed on Thursday. Five subjects were arrested at the home following the execution of the Search Warrant for various narcotics charges.

The residence was littered with used hypodermic needles. During the execution of the search warrant, the City of Flagler Beach Code Enforcement responded to the scene due to the deplorable living conditions and possible safety hazards that are now being evaluated.

Wayne Francis Paytas Jr, DOB 06/13/87, was charged with Possession of Drug Paraphernalia, Possession of a New or Legend Drug, and Possession of Cannabis. Brandon Kyler Paytas, DOB 07/16/91, was charged with Possession of a Schedule V Controlled Substance, Possession of Drug Paraphernalia, and Possession of Cannabis. Timothy Ryan Paytas, DOB 12/12/89, was charged with Possession of Drug Paraphernalia. Deidre Janeth Tilelli, DOB 06/28/78, was charged with Possession of a New or Legend Drug and Possession of Drug Paraphernalia. Nicholas Nehemia Nock, DOB 05/28/86, was charged with Possession of a Schedule II Controlled Substance and Possession of Drug Paraphernalia.

“Another handful of poison peddlers are off the streets and in the Green Roof Inn where they belong,” Sheriff Rick Staly said. “Let this be a lesson that if you try to sell your drugs in Flagler County, all agencies will work together to get you off our streets and into jail.”
