FCSO Conducting Sex Offender Checks Prior to Halloween

BUNNELL, Fla. — The Flagler County Sheriff's Office is conducting sex offender checks before and on Halloween this year.

There are currently 137 sex offenders and six predators living in Flagler County. This number includes anyone with a Flagler County address or incarcerated in the county. Of the 137, there are 28 sex offenders and probationers in Flagler County who have special conditions of their release prohibiting them from participating in Halloween-related activities. The 28 sex offenders and probationers are prohibited from handing out candy, putting up Halloween decorations, and leaving their porch lights on during Halloween night. They also must be home by 4:30 p.m. on Halloween and stay there for the remainder of the night.

FCSO's Sex Offender Unit teams up with the Florida Department of Corrections (FDOC) Probation & Parole Services to conduct in-person address checks and verify that the addresses provided to FDOC upon release from prison are valid. FDOC probation officers will accompany FCSO detectives during the visits, which include a walk-through of the residence and a reminder of the specific Halloween restrictions.

"As families prepare for Halloween, the safety of our community, especially our children, remains a top priority," said Flagler County Sheriff Rick Staly. "Our deputies are conducting these safety checks to ensure these offenders and probationers do not prey on trick or treaters. Rest assured, we will take anyone not in compliance to jail."

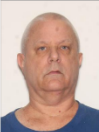

Separate from the 28 sex offenders and probationers with special conditions for Halloween, FCSO's Sex Offender Unit and Major Case Unit detectives have been going to each address of all Flagler County sex offenders during the month of October to ensure these offenders and predators comply with Florida law.

Below is the list of the registered sex offenders and probationers in Flagler County who must comply with these restrictions, including their photos, names, and addresses. FCSO urges you to avoid visiting these residences during Halloween.
